


Global Logistics M&A Recap

August 2024 Acquisitions

North America accounted for the largest number of acquisitions (by target location) in August 2024, with 40% of all acquisitions recorded. Europe accounted for 37% of acquisitions, with 13 acquisitions recorded in August. The United States was the most active country in terms of acquisitions (by target location), accounting for 12 acquisitions, or 34% of all acquisitions recorded. In terms of target services, Transportation and Software were the two most popular target services, accounting for a combined 46% of total August acquisitions.



Analysis of Logistics M&A Activity

Among the notable acquisitions in August were the moves made by NTG's acquisition of Schenker Italiana and Shmalz+Schon. NTG's previous larger strategic acquisition, which Logisyn acted as sell-side advisor on, of a sizable forwarder on the East Coast, Aries Global Logistics, opened up U.S. operations significantly for NTG. Based on these two most recent strategic acquisitions, they've shown they are continuing with their strategy to be a large global player in the forwarding space.

In general, for Logistics M&A, we'll most likely see an uptick in closings during Q4 compared to that of Q4 in 2023, which will be a great sign leading into 2025. Next year, knowing some buyers and sellers have been playing the waiting game, we expect a good year for M&A. The added tailwind of having the U.S. presidential election behind us will allow buyers and sellers to refocus on the next phase of their strategy.

Analysis of Logistics Tech M&A Activity

One interesting transaction this month was Freightos acquiring Shipsta, a freight-tender procurement platform. This acquisition integrates Shipsta's tender management capabilities with Freightos' existing spot pricing and booking solutions.

The deal terms are interesting, as the transaction seems to be strongly priced in forward-looking revenue. The transaction was financed through a combination of cash and equity, with €4.5m coming from existing reserves. While the acquisition is expected to have a moderately negative impact on Adjusted EBITDA, Freightos anticipates that potential synergies with its existing core business lines will offset this impact in the long run.

Analysis of GLS Group Divesting US Freight Divisions to DC Logistics

GLS Group, owned by International Distribution Services PLC (Royal Mail Group), is selling its US freight divisions - GLS US Freight Inc and GLS US Business Solutions Inc - to DC Logistics. The sale, set to close in September 2024, aligns with GLS's strategy to focus on its core parcel delivery services in the US market. DC Logistics views this acquisition as a step towards becoming a Top 20 LTL carrier in the United States and plans to revive the Mountain Valley Express brand. GLS US Freight operates 266 power units with 269 drivers, significantly expanding DC Logistics' current fleet. This move allows GLS to concentrate on expanding its parcel offerings, while DC Logistics gains an opportunity to enhance its LTL operations. The sale occurs as IDS undergoes acquisition by EP Corporate Group AS, potentially part of a larger corporate restructuring.

All August Acquisitions

Acquisitions of companies involved in Transportation (29%) and Software (17%) were most common in August 2024. This was followed by Temperature Controlled Transport and Freight Forwarding, which both accounted for 14% of acquisitions.
