


Global Logistics M&A Recap

January 2025 Acquisitions

North America accounted for the largest number of acquisitions (by target location) in January 2025, with 59% of all acquisitions recorded. Europe accounted for 31% of acquisitions, with 10 acquisitions recorded in January. The United States was the most active country in terms of acquisitions (by target location), accounting for 15 acquisitions, or 47% of all acquisitions recorded. In terms of target services, Software and Transportation were the two most popular target services, accounting for a combined 50% of total January acquisitions.



Analysis of the Logistics M&A Market

Having just completed two years of "normalcy" post-pandemic, the M&A market was finding the predictability necessary to value deals properly. However, 2025 has started with uncertainty. Whether fed discount rates in response to the stickiness of inflation, potential tariffs on multiple trading partners, or the impact of AI on operations and, therefore, financial performance, the market is returning to uncharted territory.

It is unclear how this will impact the M&A market. For the last few years, there has been a supply/demand imbalance, with more buyers chasing deals than sellers going to market. Some believe that the uncertainty, as well as the cost to invest in AI to keep up with competitors' offerings, will prod potential sellers to test the market, while others believe that AI will allow smaller providers to level the playing field with larger competitors, leading them to stay in the game rather than sell. More than likely, we will see a combination of the two, which should result in a more active M&A market in 2025. At Logisyn, we are seeing that already. Any downward change in interest rates will further fuel that by making deals easier to finance and at a lower cost, reducing the risk profile of the deals.

Analysis of DHL Supply Chain's acquisition of Inmar Supply Chain Solutions

DHL Supply Chain's acquisition of US-based Inmar Supply Chain Solutions (the Supply Chain Solutions division of Inmar Intelligence) is a strategic move aimed at enhancing its capabilities in the rapidly evolving e-commerce and retail sectors. As the largest provider of reverse logistics solutions in North America, DHL is positioning itself to meet the growing demands for efficient and integrated returns management. The acquisition allows DHL to expand its service offerings to include product remarketing, recall management, and supply chain performance analytics, which are increasingly vital in a market where returns are a critical touchpoint for consumers. This provides DHL with a competitive edge by offering holistic supply chain solutions, thus streamlining operations for retail customers seeking to cope with challenges such as returns abuse and rising operational costs.

Significant Acquisitions

Deal values were not available on most acquisition announcements; however, the largest deals for January 2025 (some with no values disclosed) were the following:

- SPS Commerce's acquisition of Carbon6 for \$210m
- Symbotic's Acquisition of Walmart's Robotics Business for \$200m
- DHL Supply Chain Solutions acquisition of Inmar Supply Chain Solutions (value undisclosed)

All January Acquisitions

Acquisitions of companies involved in Software (28%) and Transportation (22%) were most common in January 2025. This was followed by Freight Forwarding and Logistics, which accounted for 12% and 9% of acquisitions respectively.
