

June 2024 Acquisitions

Europe accounted for the largest number of acquisitions (by target location) in June 2024, with 56% of all acquisitions recorded. North America accounted for 29% of acquisitions, with 10 acquisitions recorded in June. United States was the most active country in terms of acquisitions (by target location), accounting for 9 acquisitions, or 26.5% of all acquisitions recorded. In terms of target services, Logistics and Transportation were the two most popular target services, accounting for a combined 55% of total May acquisitions.



Analysis of Logistics M&A Activity

We have officially turned the corner on the first half of 2024, and there still appears to be a wait-and-see attitude to the current M&A market. However, some sectors are still seeing major activity:

- The US Southern Border for customs brokers and domestic transportation, both freight brokers and asset-based carriers, remains strong.
- Freight forwarding, both ocean and air, is making a comeback. There is definitely a consolidation happening in the sector, with strategic buyers having cash on their balance sheets and expanding their footprint or geo-presence via acquisition.
- Some financial sponsors are still struggling to put a higher amount of equity to work since the debt is costing considerably more today than it did a couple of years ago. They are still raising funds and actively looking for deals. Private Equity Groups are still very active and looking for quality deal flow.

Turning to the second half of 2024, we are very bullish on the M&A markets in transportation, logistics, supply chain services, and logistics technology. Quality companies have been right-sizing to help margins come back. Freight rates are increasing. Inventories are low and need to be replenished based on demand. Stay tuned for a crazy ride over the next six months.

Analysis of Logistics Tech M&A Activity

One interesting acquisition last month was Wakeo's acquisition of Veroo Software from LKW WALTER. Veroo specializes in road transportation management and predictive analytics and adds a new tool to Wakeo's comprehensive suite of multimodal visibility tools. Julien Cote, the CEO of Wakeo, stated that this acquisition marks a significant milestone in their mission to deliver advanced supply chain visibility solutions.

The acquisition is an immediate and aggressive deployment of the Series B capital that Wakeo raised last year and is an interesting move as there has been a fairly broad retreat from some sectors and offerings over the last year by other major visibility providers.

Analysis of RXO Acquiring UPS' Coyote Logistics Unit

In one of the largest deals of the month, UPS has agreed to sell its Coyote Logistics unit to RXO, Inc. for \$1.025 bn, continuing its strategic repositioning to focus on its core small package and logistics business. This move follows UPS's 2021 sale of its road freight business. For RXO, the acquisition is transformative, doubling its revenue and making it the third-largest truck brokerage in the US. RXO expects to improve profitability through cost reductions and sees the deal as highly accretive. The transaction, typical of RXO Chairman Brad Jacobs' strategy, is likely to increase competition in the truck brokerage market. While the sale price is significant for UPS, it may reflect selling at a market low point. The deal leaves UPS more focused on its express business and contract logistics and forwarding operations.

All June Acquisitions

In June 2024, acquisitions of companies involved in Logistics (32.4%) and Transportation (23.5%) were most common. This was followed by Shipping and Freight Forwarding, which accounted for 14.7% and 9% of acquisitions, respectively.
