


# Global Logistics M&A Recap

## October 2024 Acquisitions

Both Europe and North America accounted for the most significant number of acquisitions (by target location) in October 2024, with 86% of all acquisitions recorded, respectively. Asia, Africa, and South America accounted for the remaining 14%. The United States was the most active country in terms of acquisitions (by target location), accounting for 14 acquisitions, or 39% of all acquisitions recorded. In terms of target services, Logistics and Software were the two most popular target services, accounting for a combined 50% of total October acquisitions.



## Analysis of the Current State of Leveraged Buyouts (LBOs)

For example, when you buy a house, you can "leverage" by using borrowed capital or debt to increase your potential return. This allows you to purchase at a higher price depending on your individual earnings or cash flow. Financial sponsors – such as Private Equity Funds, depend on leverage to put as little cash down (equity contribution) as possible and then borrow the rest from banks or other debt providers.

In 2023, PitchBook reported that equity contributions crossed the 50% threshold for the first time ever, compared to the average of 41% in the 10 years preceding 2022. Impacts of this trend have shown that:

- · PE firms can't afford as much as previously
- Multiples of EBITDA have been reduced
- Less cash is available for acquisition add-ons to current portfolio companies
- Lower returns for Financial Sponsors

Estimates have dry powder (available capital to deploy for acquisitions) between \$2.8 - \$3.1 trillion today. In 2015, there was less than \$1 trillion available, and looking all the way back to 2000, there was only \$150 billion. It looks like the trend of the past couple of years is about to change. The Fed announced a reduction of .25% last

week and a total of .75% for the 2024 reduction. With less equity contribution needed for acquisitions, is it time for some of that dry powder to go to work in 2025? We shall see, but the trends are looking good!

One interesting transaction last month was Accenture's acquisition of Joshua Tree Group (JTG). This move aligns with Accenture's commitment to build more autonomous supply chains. JTG, known for its hands-on approach to staff coaching and on-site management, helps companies improve warehouse efficiency. By integrating JTG's expertise, Accenture extends the coverage of its various tools and services including their Aldriven digital twins and generative Al tools.

## Analysis of Nippon Express's acquisition of Simon Hegele Group

Nippon Express's acquisition of Simon Hegele Group marks a strategic entry into specialized healthcare logistics while securing a significant presence in the German market. Simon Hegele has shown strong momentum, growing from €200M to €300M in revenue over five years, with 2,800 employees across more than 50 locations. The combination creates compelling opportunities, with Simon Hegele's healthcare logistics capabilities and German warehouse network complementing Nippon Express's global reach. The partnership looks particularly promising in Asia, where Nippon Express's strong market presence can help accelerate Simon Hegele's healthcare division expansion. This move, following the acquisition of Cargo Partner in 2023, continues Nippon Express's strategy of building a comprehensive European logistics network through acquisition.

## Significant Acquisitions

Deal values were not available on most acquisition reports; however, the largest deals for October 2024 (some with no values disclosed) were the following:

- MSC's \$768 million deal to acquire a majority stake in Brazilian port operator Wilson Sons
- Descartes' acquisition of Sellercloud for \$110 m
- InPost's acquisition of the remaining 70% of Menzies Distribution's Express and Newstrade operations for £60.4m.

## **All October Acquisitions**

Acquisitions of companies involved in Logistics (31%) and Software (19%) were most common in October 2024. This was followed by Transportation and Freight Forwarding, which both accounted for 11% of acquisitions respectively.
